

# **COMPLAINT** against Wendy Higgins Chambers

## **SLANDER AND INTENTIONAL INFLICTION OF EMOTIONAL DISTRESS**

### **Introductory Facts:**

- On March 5, 2018, I James Lawrence was called by the Westport Police and asked to turn myself in for an alleged One-Count of “Second Degree Breach of Peace” involving a still to this day unknown woman at the Fresh Market Westport on Nov. 5, 2017 – yes arrested 5 months later devoid of a sworn written statement, witness or Discovery evidence! The following week, local news reported on my arrest in a somewhat fair and balanced way with the headlines in the various newspapers via the Westport Police Press Release reading “Westport Man Allegedly Followed Woman Around Grocery Store”. “Allegedly” was fair given the details of the case. These articles were no more than a paragraph obviously allowing for Due Process of Law to sort out the issues. However, a very questionably sane woman by the name of Wendy Higgins Chambers of Westport Ct. had other malicious intentions, for after reading about my false arrest in the news around March 12, 2018, this woman took it upon herself to foment more news coverage of me, more news coverage of me that resulted in slanders, libels, numerous resulting life-changing Damages and the complete destruction of my good name.

- Wendy Higgins Chambers, having a personal story about meeting me at a supermarket months before my March 5, 2018 false arrest, made a beeline to reporter Mark Sudol at News 12 Connecticut (of all places and not the police) before the March 14, 2018 News 12 slander and libel, and then she Wendy Higgins Chambers again made another second beeline rush to reporter Sophie Cecilia Vaughan at the Westport News (after her only visit to police – March 15, 2018 - resulting in no police action of any kind despite the police fully empowered to arrest me) around March 23, 2018 after **and KNOWING News 12 was forced by my lawyer to take down their “outright false” coverage of me claiming I was “Stalking Several Women” and “Preying on Women”** featuring Wendy Higgins Chambers slanderous story. YES – this wicked woman knew I was already harmed via her actions with News 12 then goes a second repeated persistent time to the Westport News who did a similar type of defamation hit job before and after Due Process of Law this time about me **“Harassing Women for Years”**. This malicious persecution deploying major news organizations is only one aspect within this Complaint of Slander and Intentionally Inflicting Emotional Distress while other aspects of the Complaint will focus on the numerous other places where and how Wendy Higgins Chambers also persecuted me with her malicious slander.

- Evidence shows it was either Wendy Higgins Chambers or News 12 reporter Mark Sudol who controversially obtained the Arrest Warrant from my arrest, obtained against police matters of practice to redact from release the kind of unproven and un-provable information she is slanderously moving around town and to major media outlets for her persecution. Evidence of this police “matters of practice to redact from release” are in emails from the lead FOIA officer at the Westport Police.

- I launched a federal lawsuit against Altice USA/News 12 in December of 2018 - 9 months after their slander and libel and this suit is currently before the Second Circuit Court of Appeals. News

12 agreed to take down their slanderous and libellous coverage of me 2 days after their mistakes back in March 15, 2018. I chose to start my legal action with News 12 to get to as many facts as possible via the chronological chain of events from where Wendy Higgins Chambers initially started her persecution.

- I launched another federal lawsuit against Hearst Communications/Westport News in February of 2019 after waiting the maximum 2 years time to file my libel lawsuit. Unlike News 12, the Westport News has never taken down their coverage of me after formal letters asking them to do me the same courtesy as News 12 did who removed their libel from the Internet fomented by and via and starring - Wendy Higgins Chambers.

- I met Wendy Higgins Chambers **9 months before** my false March 5, 2018 arrest for Second Degree Breach of Peace for an alleged “following a woman and getting into personal space” within a Fresh Market in Westport of a still to this day unknown woman on Nov. 5, 2017 that has resulted after 2+ years of being offered a Nolle Prosequi and me asking for a trial to expose various corruption but only results in me never being afforded a trial and thus NOT GUILTY.

- I have patiently waited the maximum 2 years to file this complaint so to have as many details as possible to present to the court.

- I had met Wendy Higgins Chambers at a Stop and Shop market in Westport **9 months before** the March 5, 2018 false arrest and had a at least 10 minute peaceful and innocuous conversation about various topics with her within the market and at the check out counter and then at our cars giving her my business card (that existed within my car) and links to my various websites.

- I then never see this Wendy Higgins Chambers again. I live in the area part-time and for the most part run into friends at the market when I come back for short periods of time. I never see this person again thus never had any contact with this person.

- We had a **one-time peaceful contact** at a Westport supermarket named Stop and Shop 9 months before the March 5, 2018 false arrest of one-count of Second Degree Breach of Peace. That is it. I knew and know nothing of her and could not even recognize her during and after her persecution. Crazy to say the least.

- I do not even know anything about Wendy Higgins Chambers nor ever cared to know anything about her outside of spontaneously giving her my business card and writings aka websites after a peaceful conversation that resulted in NO complaint to police, NO complaint to store manager, or even NO complaint to me for she apparently had my business card/contact and could have made a complaint to me as well. NOTHING – NO COMPLAINTS 9 months before the arrest.

- At our one-time contact that **was 9 months before** my March 5, 2018 arrest for one-count of Second Degree Breach of Peace, we merely and innocuously talked about various things resulting in no complaint anywhere – no complaint to me despite having my contact information, no complaint to store managers, and no complaint to the police. **HOWEVER, 9 months later what somehow results is her malicious decision to go to the major press within the area – the March 14-15, 2018 slander and persecution via News 12 Ct. (of all people and not the police) and then AGAIN her March 23, 2018 slander and persecution via the Westport**

**News (after her March 15, 2018 visit to police that resulted in no police action and not even a call to me or an individual incident report – nothing!) – these malicious intentions and extreme repeated and persistent slanderous actions being the chief issues at hand.**

- YES - After Wendy Higgins Chambers reads about my March 5, 2018 arrest most likely sometime on or after March 12, 2018, she goes to News 12 Mark Sudol (of all people not even the police) with her various slander resulting in News 12's March 14 and March 15, 2018 slander and libel (now being contested via a lawsuit). Briefly – News 12 and Wendy Higgins Chambers attempted to do a special story 10 days after my arrest by portraying me as ***“Arrested for Stalking Several Women” and “preying on women”***. **This news report was looped every 30 minutes for 2 days March 14 and March 15, 2018 on News 12.** All broadcasts and articles are in my possession to be presented as evidence at trial. Evidence shows it is this nasty woman Wendy Higgins Chambers who fomented all this life damaging coverage. It also appears Wendy Higgins Chambers may have been the one who got her claws on the Arrest Warrant against police matters of practice to redact from release the information she slanderously moves around various people and organizations and stores. The proof of this police matters of practice to redact from release the kind of information Chambers and reporter Mark Sudol comes in the forms of emails from the lead FOIA officer from the Westport Police, amongst other sources to be presented.

- A call from my lawyer to News 12 on March 15, 2018 who explains how News 12 got the arrest wrong (it had nothing to do with stalking let alone preying) and News 12 ceases all reporting of me. **YES News 12 takes all coverage of me off their websites and attempts to scrub the Internet of their coverage of me that was fomented by and includes slanderous quotes by Wendy Higgins Chambers.** This entire experience of having News 12 reporter Mark Sudol come to my house on March 14, 2018 with his news van secretly parked down the street ambushing me with questions about the arrest for – one count of Second Degree Breach of Peace – **is fomented, instigated, perpetuated by Wendy Higgins Chambers.** Yes – the only one being veritably stalked or preyed upon is I James Lawrence.

**FACT:** had Wendy Higgins Chambers never got involved with things she knew absolutely nothing about – none of this resulting outright false coverage and resulting ongoing Damages would have happened.

**YES THIS ACTUALLY HAPPENED BUT WE ARE ONLY GETTING STARTED HERE TO SHOW HOW WICKED THIS VERITABLE NASTY WOMAN IS ...**

- **SO ...** After seeing that News 12 had to take down their “outright false” coverage of me because of getting the arrest wrong and potentially committing various libel and slander, **Wendy Higgins Chambers knowing I was already unjustly harmed by her then goes to the Westport News reporter Sophie Cecilia Vaughan** with News 12's false narrative and her various personal slander. Just utter wicked malicious intentions and evilness. On March 23, 2018 another special hit job is published in the Westport News and yes once again fomented by and featuring the mean-spirited nasty woman Wendy Higgins Chambers weeks after my simple arrest and all before Due Process of Law and after Due Process of Law (in reference to material they libellously and slanderous play with).

- Records show there is no reference or complaint about me on Wendy Higgins Chambers' social media or Twitter or Facebook pages at the time of our meeting in 2017 or at the time of my March 5, 2018 arrest or any other time, for it is these social media platforms most people attempt personal vendettas and persecution devoid of police investigations NOT major media organizations! Wendy Higgins Chambers most significantly chooses the largest cable TV news organization in the Tri-State area - NEWS 12 Ct., and then chooses to go to the WESTPORT NEWS **knowing News 12 had to take down News 12 reporter Mark Sudol and Wendy Higgins Chambers' coverage of me.** **YES this crazy woman KNOWING OF THE VARIOUS UNRESOLVED CHAOS AND DAMAGES THAT SHE INSTIGATED AND CREATED persistently continues her slanderous persecution of me by then going to a 21 year old Westport News reporter named Sophie Cecilia Vaughan to push her slanderous persecution all before and after Due Process of Law.** What the hell is going on with this obviously imbalanced nasty woman I never ever saw more than once in my life let alone be able to recognize? This is very strange to say the least with many needed questions to be answered at trial and jury of my peers.

- ONCE AGAIN this Westport busybody **knowing** I was already harmed by her feeding News 12 slanderous material, goes on to persecute me even more **knowing** News 12 harmed me and could not stand by what she and Mark Sudol attempted to do - report on me as a ***“Arrested for Stalking Several Women” and “preying on women”***. Meanwhile I was arraigned March 14, 2018 awaiting Due Process for a ONE COUNT OF SECOND DEGREE BREACH OF PEACE.

- The Westport News went on to create a similar type of news March 23, 2018 story fomented by and starring Wendy Higgins Chambers (the only woman) in the form of articles that accuse me of being a ***“harasser of women” and “a creep” etc... (see full transcripts and articles)*** amongst other libellous issues, along with even more Wendy Higgins Chamber's personally numerous and persistent and obviously malicious lies and slander to be presented.

- **Wendy Higgins Chambers never made a complaint to police until after her March 14, 2018 News 12 persecution to where the Westport Police do not even have a individual police report of her defaming nonsense story. YES – the Westport Police do not have an individual Incident Report of all this sick woman maliciously did to me!!! Meaning – she went to the police on March 15, 2018 after the News 12 March 14-15, 2018 slander and libel and before the Westport News' March 23, 2018 slander and libel caused by Wendy Higgins Chambers. The Westport Police were fully empowered to arrest me after hearing her story for the statute of limitations was not in effect (1 year) but they opted not to arrest me, or call me, or write an individual police report of her slanderous insanity! Why then is it this crazy woman feels she has the right to go around town and to major media organizations to forever hurt me even more after her visit to police who investigated and found her story not worthy of any action?**

- What a sick gender warring time we are in! We are in the worst gender war in not only all human history but also of any species in history ever. And New York is a hub of this madness. The following story shows a huge injustice certainly worthy of a jury of my peers. This mentally imbalanced woman Wendy Higgins Chambers has obviously been watching and reading too

much news about the MeToo Movement and Times Up Movement and Nasty Woman Movement with women accusing men of sex harassment via the media, and somehow decided to take our innocuous one-time supermarket encounter HAVING ABSOLUTELY NOTHING TO DO WITH METOO SEX HARASSMENT LET ALONE ANY KIND OF HARASSMENT that **never** resulted in any complaint to anyone as some kind of material to do a similar type of MeToo public persecution via the media. Sick! I am utterly nauseous having to relive the mentally abusive chain of events from this obviously very sick woman but have no other choice 2 years later for her effects on the community and nation and world at large are forever life changing to say the least. Justice will see to it that she pay for all the resulting Damages from the forever-growing LIST OF OVER 50+ DAMAGES from her malicious persecution for the one very important fact remains – after and before Due Process of Law I am NOT GUILTY **and still to this day have a clean Ct. record to which Wendy Higgins Chambers knew when she committed her multiple acts of slander and intentional infliction of emotional distress.**

**- In regards to my accusations of slander by Wendy Higgins Chambers I will be addressing her ACTIONS WITH AND QUOTES WITHIN the March 14-15, 2018 News 12 Connecticut Broadcasts and articles with reporter Mark Sudol.**

**- In regards to my accusations of slander by Wendy Higgins Chambers, I will be addressing her ACTIONS WITH AND QUOTES WITHIN the March 23, 2018 Westport News article by reporter Sophie Cecilia Vaughan.**

**- In regards to my accusations of slander by Wendy Higgins Chambers I will be addressing evidence of her NOT ONLY APPROACHING THESE MAJOR MEDIA but APPROACHING VARIOUS ESTABLISHMENTS within the area to push her slander. It has been proven that Wendy Higgins Chambers visited nearly every market in the Westport area sharing the news from the arrest and attempting to get me banned from various establishments – Stop and Shop, Balduccis, multiple location Whole Foods, etc... and God knows where else.**

**- In regards to my accusations of Wendy Higgins Chambers actions causing severe and certain emotional trauma/mental anguish/intentional infliction of emotional distress/negligent infliction of emotional distress I will be addressing introductory evidence briefly listed here followed by a complete list in the coming future.**

**- In regards to the various types of Damages caused by Wendy Higgins Chambers I will show an introductory list of the effects on my life resulting from the malicious slanderous actions by Wendy Higgins Chambers and then a future list of all the ongoing financial burdens and costs because of the slanderous actions of Wendy Higgins Chambers.**

## **Initial Known Stories and Complaint against Wendy Chambers**

Wendy Higgins Chambers reads about my March 5, 2018 false arrest for ONE-COUNT of Second Degree Breach of Peace for as the fair March 12, 2018 articles from various media via

the official Police Press Release states “*Westport man arrested for following a woman at a local market*” or as the Arrest Warrant states “*allegedly following a woman at a local market and getting into personal space*” and somehow starts to brew a vindictive agenda to harm me. Why? Why is she doing this? When did she get her claws on the Arrest Warrant? Who and how many did she approach? There are also many lingering questions as to how she did this for police themselves question the resulting doxxing of Arrest Warrant material they claim is redacted from release.

At the time of my arrest, ALL the media at large did a fair and simple few lined articles on the arrest and only the actual first time Ct. arresting incident and allowed for Due Process of Law to commence affording me Presumption of Innocence and allowing for proper Due Process of Law to sort out the issues within the case. No media attempted to ascertain the Arrest Warrant and report on things beside the actual arrest for one count of Second Degree Breach of Peace.

BUT what does this crazy Wendy Higgins Chambers woman do who I peacefully met once in my life - at a public supermarket named Stop and Shop Westport 9 months before? Wendy Higgins Chambers (unlike any person - hundreds I have met in the area - including the lack of Complainant from the actual arrest) makes a beeline straight to whom to follow through on her persecution? .. - to police to investigate and make proper conclusions? NO. She did not approach police before News 12. Did she even go to the police after her alleged “*preying on woman*” supermarket incident 9 months before in 2017? NO. **This nasty woman after reading about my first time arrest for one count of Second Degree Breach of Peace makes a beeline to News 12 Ct. of all people** and News 12 Ct. reporter Mark Sudol who together somehow dubiously ascertain and attempt to deploy the Arrest Warrant replete with subjective, unproven, and unprovable material and KNOWING this material they wish to report upon had already been fully investigated resulting in no arrests cases long closed aka never arrested in Ct. – NOT GUILTY, these two disgusting agenda-driven fools collude to “outright falsely” report on my arrest being an arrest for “*stalking several women*” and “*preying on women*” and not an arrest for a single count of Second Degree Breach of Peace. Wendy Higgins Chambers and News 12 Mark Sudol were playing with things they knew nothing about - contents of the Arrest Warrant and the investigation all before and after Due Process of Law. They and only they are the only ones attempting to do this – subjectively interpret an Arrest Warrant resulting in various types of defamation. AND ONCE AGAIN DAYS LATER – NEWS 12 CHOSE TO TAKE DOWN ALL THEIR COVERAGE OF ME (MARCH 14-15, 2018) THAT FEATURED THEIR ANTAGONIZING COHORT WENDY HIGGINS CHAMBERS.

**FACT:** Wendy Higgins Chambers and News 12’s Mark Sudol and once again Wendy Higgins Chambers and Westport News’ Sophie Cecilia Vaughan were playing with information within the Arrest Warrant information that police as a “matter of practice redact from release”. Evidence in the form of lead FOIA officer Emails and Facebook postings and actual Police Press Releases will show the police never meant for the unproven and unprovable long gone information they slanderously played with to be made public especially in the way these conniving cowards did.

**FACT:** They knew that the alleged incidents mentioned in the Arrest Warrant resulted in no arrests and were cases closed for as the Arrest Warrant itself states I have no Ct. criminal history aka never arrested in Ct. thereby showing any alleged past incident (without a name,

sworn written statement, let alone arrest) was foggy and demanded more facts – like reporting on the outcomes of the investigations of any alleged supermarket encounter (mysteriously devoid of names) or just staying the hell out of what was none of her business and allow for Due Process of Law with affording me Presumption of Innocence that ALL the other women of the world did. Wendy Higgins Chambers took this dubiously ascertained Arrest Warrant information with or from News 12 reporter Mark Sudol to Westport News reporter Sophie Cecilia Vaughan knowing the material she is attempting to share are long gone closed cases that were fully investigated resulting in no arrest thereby knowing the information she is playing with is unproven and forever un-provable.

**FACT:** I HAVE ONE CONVICTION ON MY RECORD THAT IS FROM 1996 FOR A DOMESTIC VIOLENCE CHARGE IN CALIFORNIA. ALL ELSE MENTIONED IN THE ARREST WARRANT WHERE CASES RESULTING IN NO ARRESTS, OR AN ARREST WITHOUT A CHARGE, OR CHARGES WITHOUT CONVICTIONS. MEANING - I WAS AND AM NEVER GUILTY. But NO – we are in the insanely unjust Guilt by Accusation social media zeitgeist unlike any time so let loose Wendy Higgins Chambers to do her own subjective interpretation of police matters and own personal hit job before Due Process of Law and after Due Process of Law. Sick to say the least.

**Here is the text from Wendy Higgins Chambers with News 12 Ct.:**

*“a local woman who did not want to be identified told News 12 today that a man followed her to her car months ago at a Whole Foods (wrong market) parking lot and asked her out”. JESUS really. This is news?!! “This is a guy you know walking around the grocery stores (it is called shopping) **preying on women** and it is really frightening to wonder what could possibly happen”, and then – “This is something I (her and only her) just wanted people to know about because it (what is it) **is not just happening it (what is it) is happening a lot**” (only police incidents in Westport and only Westport and a false number despite living around the country and world with no incidents at all).*

WHAT IS **“THIS” “IT”** THAT MAKES THIS WOMAN FEEL SHE NEEDS TO GO BEYOND A POLICE INVESTIGATION AND RESULTS OF POLICE INVESTIGATIONS AND AGAINST POLICE MATTERS OF PRACTICE TO REDACT FROM RELEASE THE KIND OF AMBIGUOUS MATERIAL SHE IS PLAYING WITH AND PERSECUTE ME BEFORE AND AFTER DUE PROESS OF LAW VIA THE TOP CABLE TV NEWS PROGRAM IN THE TRI-STATE AREA AND THEN VIA THE LARGEST NEWSPAPER IN THE TOWN OF WESTPORT OWNED BY THE LARGEST MEDIA CONGLOMERATE IN THE NATION THAT REACHES GLOBAL AUDIENCES LET ALONE OTHER PLACES SHE VISITS SLANDERING ME? **OVER WHAT!?!?** - WALKING UP TO HER AT A PUBLIC MARKET WITHOUT ANY PREVIOUS WARNINGS FROM HER LET ALONE NEVER ANY COMPLAINT TO ANYONE? THIS IS INSANITY TO SAY THE LEAST. THIS WOMAN DOES NOT KNOW 99.99% OF ANYTHNG ABOUT THE ARREST AND MY LIFE YET IS THE SELF-APPOINTED AUTHORITY TO PROTECT WOMEN FROM ... WHAT? - BEING TALKED TO AT A MARKET BY SOMEONE WITH NO CRIMINAL RECORD. TALKED TO AT MARKETS - THE AMERICAN PUBLIC SQUARE WHERE I AND OTHER PEOPLE MEET ALL KINDS OF PEOPLE EVERY DAY. THERE WAS NEVER ANY STALKING, PREYING, HARASSMENT, OR EVIDENCE OF ANY CRIME

WHATSOEVER YET SEE THE DAMAGES TO MY LIFE BECAUSE OF WHAT THIS PSEUDO METOO MARTYR NASTY WOMAN DOES TO ME.

SO a call from my lawyer and News 12 then took down their slander and libel from their websites (now being contested in a Slander and Libel case via Appeals Courts and if necessary to the U.S. Supreme Court) and attempted to scrub the Internet of their slanderous coverage of me. This was a proper first step to repair the ongoing Damages that are happening to me every day. ALL BROADCASTS OF THESE PROVEN “OUTRIGHT FALSE” REPORTS ARE IN MY POSSESSION THAT HAVE WENDY HIGGINS CHAMBERS ACCUSING ME OF “**PREYING ON WOMEN**” AT LOCAL SUPERMARKETS AND THAT “**it is really frightening to WONDER WHAT COULD POSSIBLY HAPPEN**”..

English: Wonder - to speculate curiously or be curious about; be curious to know.

“**IT IS REALLY FRIGHTENING TO WONDER WHAT COULD POSSIBLY HAPPEN**”.. “**frightening**”.. in broad daylight at a public supermarket shopping from someone with no Ct. criminal history – Westport Ct. being the alleged place of me the big bad supermarket guy. And “**possibly happen**” .. meaning - nothing actually happened yet this insane woman can go around town and to the largest media organizations in the area and push unproven accusations resulting in life changing Damages that the police found on March 15, 2018 when she visited them to be not worthy of any police action let alone a individual police report – not even a call to me. Just utter persecution.

Perhaps a proper inquiry into my criminal record or as the Arrest Warrant states as this busybody dubiously read with or via News 12 Mark Sudol, a dubiously ascertained Arrest Warrant that clearly states **I have no CT. criminal history!** But no, this woman has some kind of arrogant self-appointed mission before Due Process of Law and after Due Process of Law.

**DOES WENDY HIGGINS CHAMBERS CEASE HER PERSECUTION KNOWING NEWS 12 GOT IT WRONG AND CHOSE TO TAKE DOWN THEIR OUTRIGHT FASLE ACCOUNT OF THE ARREST?**

**NO!!!. THIS EVIL WOMAN PERSISTS HER SLANDEROUS ATTACK KNOWING I WAS ALREADY UNJUSTLY HARMED AND DAMAGED BY HERSELF AND NEWS 12 AND PROCEEDS TO TAKE HERSELF AND THE DUBIOUSLY ASCERTAINED ARREST WARRANT INFORMATION TO THE WESTPORT NEWS ALL BEFORE DUE PROCESS OF LAW AND AFTER DUE PROCESS OF LAW FOR THE WESTPORT NEWS’ SPECIAL HIT JOB WEEKS AFTER MY ARREST UNLIKE ANY OTHER MEDIA!!!! EVIL. ALL THIS MADNESS IS HAPPENING BECAUSE OF WENDY HIGGINS CHAMBERS AND ONLY WENDY HIGGINS CHAMBERS.**

**potential slander and libel fomented by her** to which News 12 admit their attempt at this special story before Due Process of Law and after Due Process of Law (investigations that resulted in never being arrested in Ct. before let alone no convictions) was not appropriate let alone legal in most ways (I was not arrested for stalking women), Wendy Higgins Chamber then takes the unproven and un-provable information (all statute of limitations in effect for the material she is pushing let alone lack of any name of the material she is pushing for Wendy Higgins Chambers is the only name in this fiasco but she herself Wendy Higgins Chambers without a individual police report) ... takes information from a controversially ascertained Arrest Warrant (against police matters of practice to redact from release the information she attempts to play with) **and makes ANOTHER SECOND MAD BEELINE this time to 21 year old dyed in the wool feminist reporter at the Westport News Sophie Cecilia Vaughan**, and together proceed to attempt to finesse a similar type of special interest story before and after Due Process of Law (unlike any other media and weeks after the arrest) this time using the words *“harassed women for years”*. **FACT: The words *stalk and harass and persecute* are defined as - repeated persistent continual acts toward someone.** NONE OF MY ALLEGED UNPROVEN AND UN-PROVABLE CASES LONG CLOSED INCIDENTS AT SUPERMARKETS AND ONLY SUPERMARKETS CAN BE DEFINED IN THIS SLANDEROUS AND LIBELOUS WAY.

BUT YES – THIS WENDY HIGGINS CHAMBERS WENT TO AT LEAST 2 MAJOR MEDIA ORGANIZATIONS AND MULTIPLE STORES and god knows where else ... (A VERITABLE - REPEATED, PERSISTENT, CONTINUAL PERSECUTION) about our peaceful crossing of paths 9 months before at a local market I frequent every day that resulted in no complaints to anyone and no action by police yet now ANOTHER hideous media article fomented by and starring this sick Wendy Higgins Chambers sits out for the world to see me as some kind of serial *harasser*. What kind of place and time are we in – I live all around the world for 54 years and no evidence of any supermarket harassing let alone any harassing anywhere exists. **If there exists any kind real justice in this country this Wendy Higgins Chambers would be in jail for what she did to me.**

SO - **The Westport News** despite any evidence of any *stalk or harass or prey*, any previous arrest, or any conviction of anything from not only the March 5, 2018 one-count Second Degree Breach of Peace arrest but anything mentioned in the libel and slander - complete inability whatsoever to prove there was any *stalk or harass or prey* ever as evident in the long gone case closed alleged “incidents” from the dubiously ascertained Arrest Warrant before and after Due Process of Law aka KNOWN no Ct. criminal record, **proceeds to leave their now contested libel out on the Internet and their websites for the past 2+ years and counting (unlike News 12 who took remedial steps taking down their false unproved and un-provable coverage) thereby creating huge amounts of Damages to which this crazy veritable nasty woman Wendy Higgins Chambers fomented all the coverage and resulting Damages - Wendy**

"*He showed up in front of my car and scared the crap out of me. He said he wanted to go out with me and I said I didn't want to go out with him* (all evasive of details – we had a 10 minute conversation – utter fabrications)," Chambers said, adding, "*He's a creep.*" (OY .. any more news of the infinite personal feelings of men being creeps around the world).

**FACT: I NEVER COMMITTED A CRIME WHATSOEVER.** If Wendy Higgins Chambers and News 12 Mark Sudol and then AGAIN Wendy Higgins Chambers and the Westport News Sophie Cecilia Vaughan merely showed common wisdom that other news outlets did by refraining from digging into a dubiously ascertained Arrest Warrant and let Due Process commence and work out ambiguities, I would not have lost my name and reputation forcing me to find a safe (YES SAFE) sanctuary in a totally different country so to not continue being targeted, profiled, and mentally abused in various ways. **Yes – big time mental abuse. But even this safe sanctuary in another country mysteriously became spoiled, because while in 2018 the Westport News could not be Googled/ascertained abroad, now since 2019 the Westport News can be Googled/ascertained not just via the Westport News websites but also through the Associated Press (AP) in general. SO – I am now easily targeted and profiled all around the world.**

**Here is an introductory brief description of some TRAUMATIZING things that have happened to me since March 2018 that I know and have evidence of, and how my Emotional and Mental Anguish claims have merit.**

**1:** While merely visiting here in Ct. during 2018 and taking care of business to resolve lingering issues so I could get out of the area the rest of my life, I was denied membership to Stamford's Chelsey Piers fitness and pool because of what Wendy Higgins Chambers slander and the Westport News' libel did to me. I am swimmer and there are very few clean places/50 meter pools to pursue my swim training and therapy. Yes I lost my HEALTH clubs - plural!!! This ban via a cowardly Email without an interview (like little Westport News' reporter Sophie Cecilia Vaughan cowardice not affording me a proper interview so to get some facts straight) happened after the Westport YMCA earlier banned me from their establishment (also via a cowardly Email). I responded with an Email to state my case to the Westport YMCA calling out the membership director with a proper dressing down he deserved. I then returned from Europe recently to find he deviously and against common YMCA policy put me on a national ban of all YMCAs. I tried to get an explanation and another Westport YMCA director mentions in a recorded phone conversation **"my arrest record"** (aka how Westport News' shadily doxxes my **"arrest record"** without showing any actual convictions) despite the fact I was never arrested

in Ct. before this false one count of Second Degree Breach of Peace arrest and my sole conviction in my life is from 1995 in California. Since there already is evidence of Wendy Higgins Chambers approaching various stores with the article of my arrest there is a possibility she made contact with the YMCA as well aside from contacting the world at large via News 12 and then the Westport News.

Wendy Higgins Chambers' slander and the Westport News libellous muckraking resulted in maliciously misinterpreting unproven grey information that became recklessly hyped and doxxed to the world, slanderous and libellous muckraking that was beyond common journalist practice when reporting on an arrest let alone first time arrest in Ct.. The recent arrest of one count of Second Degree Breach of Peace is no grounds for a YMCA ban let alone a national YMCA ban. YMCA policy is to ban or nationally ban if there is an incident of violence on their premises or if the member is on a sexual predator list. NONE OF THESE APPLY TO ME WHATSOEVER YET THE WAY WENDY HIGGINS CHAMBERS AND NEWS 12 AND THEN WENDY HIGGINS CHAMBERS AND THE WESTPORT NEWS REPORTED ON ME GAVE THE YMCA FEELINGS TO INTERPRET MY ARREST FOR ONE COUNT OF SECOND DEGREE BREACH OF PEACE AS BEING SOME KIND OF SEXUAL PREDATOR!!.

Once again - Where is there a proper **“arrest record”** to ban me? There is none. BUT there is hyped up out-of-context false information aka **SLANDER and libel** in the public now because of the WENDY HIGGINS CHAMBERS and Hearst/Westport News. Yes all of this and a whole lot more is happening to me because of the information Wendy Higgins Chambers and the Westport News created and empowered others to hype and falsely run with. A truly sick time in America where we read of various bans happening to people for various reasons (most often differing politics) where everyone wants to use the overly free social media and Internet access to make some kind of social statement and persecute someone yet many times at the expense of innocent people and yes - DONE ILLEGALLY.

**2:** Because of Wendy Higgins Chambers via News 12 and then Wendy Higgins Chambers via the Westport News, I am now being profiled by Air B-n-B and other hotels while attempting to live abroad and denied business at their establishments. These bans have made transitioning to a new city and new life very difficult and costly. In addition to not being able to properly find spontaneous housing, I also have the problem of being denied an apartment because of the slanderous way Wendy Higgins Chambers persecuted me via the media. While looking to rent I experienced questions about the Westport News article readily Googled when searching my name. Letters from some of these renters will be presented as evidence. I do not even dare attempt to invest in a condominium unit.

**3:** In Ct. I also have had 2 food markets – Balduccis Westport and Whole Foods Fairfield ban me because of how Wendy Higgins Chambers via News 12 and then Wendy Higgins Chambers via the Westport News reported on me. In both cases the markets' managers approached me and referred to News 12 and Westport News coverage and to the wicked woman Wendy Higgins Chambers. This woman physically approached them as well much like she did at Whole Foods in Westport/Norwalk.

**4:** I also lost 2 tenants because of how Wendy Higgins Chambers via News 12 and then Wendy Higgins Chambers via the Westport News reported on me, tenants who saw and read the information created by the Wendy Higgins Chambers and News 12 and then Wendy Higgins Chambers and the Westport News. I also lost other potential tenants who after visiting my home, Googled me to find the Wendy Higgins Chambers' fomented media muckraking. Now the apartments are sold in an effort to permanently leave Westport.

**5:** Wendy Higgins Chambers slander via the Westport News reporting made its way into Fairfield County Facebook Moms page. I myself was planning on settling back in the area after living in California from 2005-2016 and planned on having children but that plan is long gone. There are no longer immediate plans to have a family and participate in the school system.

**6:** Because of the way Wendy Higgins Chambers deployed the media against me I have had to spend time re-adjusting my social media presence where I changed my name within various accounts of mine when I could, and YES will be changing my name after all lawsuits are finished.

**7:** Because of Wendy Higgins Chambers **I do not even dare/attempt to advertise my businesses and pursue other ventures now nor allow some potential employer to Google me. I do not dare attempt to get a coaching or teaching job. I am also a writer and have shelved most projects and have taken most of my websites off the Internet. I had many plans for public service with my socially redeeming websites and politics and that is now delayed for years and possibly forever in this sick and overly biased country looking to persecute without proper evidence let alone convictable evidence.**

**8:** Because of Wendy Higgins Chambers I am constantly perusing the Internet to make attempts to keep the unjust slanders and libel out of other news and information sources. I now have to chase down 3 articles that have parroted the same slander created by the Westport News via Wendy Higgins Chambers.

**9:** I left the area seeking a home in a totally different country with a different language so not to be "Googled" but this brief respite too has become destroyed given the facts the slander and libel is now available worldwide via the Associated Press chaired by Steven Schwartz who happens to also be the president and CEO of Hearst Communications/Westport News. A strange happening for the Westport News since the dawn of the Internet was never available abroad until 2019.

**10:** Because of Wendy Higgins Chambers I lost friends, girlfriends, abilities to get friends and girlfriends, etc... I am a musician and I do not drum nor sing the way I used to, nor is there laughter in my life, etc... This disgusting person Wendy Higgins Chambers has destroyed my life by not affording me proper, normal, and common Presumption of Innocence and respect for Due Process of Law.

**11:** Also because of Wendy Higgins Chambers' media persecution my family (mother and father) have put their house on the market/selling their home in Westport after living there 54 years because of the slander and libel and they too also have costs leaving the area.

**12:** Since the slander and libel, resulting lawsuits of mine (2-3 more of them now) that have cost money and time AND HEALTH (time I could be doing other things as usual) would not have come about if the Wendy Higgins Chambers just minded her business and allowed for Due Process of Law without committing slander against me. Yes I have to clean up these various bans like the national ban from the YMCA via a lawsuit. I also have other lawsuits resulting from the actions of Wendy Higgins Chambers that will be presented as part of the ongoing Damages.

**These are just some of the mentally abusive Damages I have painfully come in contact with. I do not even live here anymore. Imagine all what I do not know and all I will constantly come to know of. ONCE GAIN - I do not even live in Connecticut or USA full time anymore because of the utter destruction of my name and life. Imagine if I stayed in the area and imagine all the possible stories from every day blow back/mental abuse if I was going about my law-abiding 54-year old life as I should be empowered to do without unnecessary FEAR, ANXIETY, MENTAL ABUSE AND EMOTIONAL ANGUISH.**

I can go on for pages upon pages upon pages with numerous examples of mentally abusive and traumatic effects as to why this Complaint has merit and deserves a jury. Wendy Higgins Chambers took a law-abiding man's life and totally destroyed it. PERIOD! YES – 54 years of staying out of trouble with a sole conviction from 1996 of domestic violence 25 years ago in California. Now because of Wendy Higgins Chambers via News 12 and then Wendy Higgins Chambers via the Westport News' actions, my life is in constant danger. I basically have a target on me. So long as their unproven and never can be proved slander and libel is allowed to sit out in the Internet the more various stories of my mental anguish that **can only be tied to the Wendy Higgins Chambers via News 12, and then AGAIN Wendy Higgins Chambers via the Westport News slanderous and libellous actions.** If Wendy Higgins Chambers merely left the simple one count of Second Degree Breach of Peace arrest alone (as proper media originally did 2 weeks before her slander) and allowed for Due Process of Law to work its way through the system NONE OF ALL THE NUMEROUS LIFE-CHANGING ONGOING DAMAGES I HAVE EXPERIENCED (see **Coming List of Damages**) WOULD HAVE HAPPENED!

WHY DID NEWS 12 AND THEN WESTPORT NEWS CHOOSE THESE SPECIAL TYPES OF STORIES? WAS I BEING EXTREMELY TARGETED IN WAYS OUTSIDE OF THE ARREST? EVIDENCE EXISTS IN REGARDS TO THIS QUESTION THEREBY CONCLUDING A TRIAL IS MOST CERTAINLY IN ORDER.

**FACT: 99% of the articles written about a particular arrest stick to the arresting charge and allow for proper Due Process of Law and do not doxx people of unproven and never can be proven material devoid of an arrest let alone conviction. Actual criminals are arrested and not doxxed the way I was via some local busybody lunatic seeking attention without any police investigation to back up her persecution. What we have here is obvious agenda-driven malice resulting in ongoing mentally abusive defamation.**

**SOME REPERCUSSIONS** – Wendy Higgins Chambers via News 12 and then Wendy Higgins Chambers via the Westport News turned me into a boogey man/pariah. I have plenty of stories –

**Once again, after reading typical Mental Anguish claims, I realized the fact that what I have experienced on a daily basis (whether living here in U.S. or not) from multiple sources is far more a case for Mental Anguish than typical Mental Anguish claims like having a gun pointed at you, which is a one time occurrence, while my occurrences are constantly going on with various loses/damages and with no end in sight.**

Wendy Higgins Chambers via News 12 and then Wendy Higgins Chambers via the Westport News reporting on my arrest was damaging in ways that need to be presented in all details given the very raw and dangerous times that America is experiencing with the MeToo movement/Nasty Woman movement /Times Up movement, because many men are being tried and convicted via the media before they receive any proper Due Process of Law. Many times men are forced to resign their livelihood posts and lose significant aspects of their life before any Due Process of Law. What makes my case so outrageous and immediate in the sense of the need to be national news to be learned from, is how Wendy Higgins Chambers via News 12 and then Wendy Higgins Chambers via the Westport News seemingly conflated me with the sex harassment cases going on in the current zeitgeist **despite the FACT that my case had nothing to do with “sex harassment”**, let alone nothing to do with any proven **“stalking women”**,

“preying on women”, harassment” or “harassing women for years” and the other lies to which Wendy Higgins Chambers via News 12 and the Westport News so negligently reported that resulted in over 50 major damages to my life. SEE COMING EVIDENCE OF SEARCH ENGINES ASSOCIATING MY NAME WITH SEX HARASSMENT. ONGOING DAMAGES.

**I look forward to bringing forth all the EVIDENCE of Wendy Higgins Chamber’s malicious defamation, and all the Damages to my life because of her Slander and obvious Intentional Infliction of Emotional Distress.** Presentation of various evidence like the actual Dispatch Tapes from the false arrest she knew and knows nothing about, more evidence in the forms of FOIA Officers Emails about matters of practice to redact from release information Wendy Higgins Chambers attempts to falsely and maliciously play with, evidence of Police Press Releases, evidence of no police action from her eventual complaint to the police aka no individual police incident report, evidence from letters from store managers and employees she approached, letters from employees from Whole Foods contradicting her lies, etc... all the evidence about my lack of criminal history that will show proper perspective COMPARED TO THE SLANDEROUS WORDS AND ACTIONS BY WENDY HIGGINS CHAMBERS AND HER FOMENTING TWO – 2 (BIG DEUCE) LIBELLOUS MAJOR MEDIA COVERAGES AND PUSHED SIMILAR SLANDER AROUND TOWNS RESULTING IN FOREVER LIFE-CHANGING DAMAGING WAYS.

This nasty woman Wendy Chambers did not know any details about my March 5, 2018 arresting incident outside of the simple news coverage saying I was “*allegedly following a woman at a market*” and arrested for one count of Second Degree Breach of Peace. EVERYONE READ THIS YET WENDY HIGGINS CHAMBERS AND ONLY WENDY HIGGINS CHAMBERS DECIDED TO PERSECUTE ME HENCE PERSECUTION BEING A VERY APPROPRIATE TERM. It is Wendy Chambers who fomented the extreme lies/slander/defamation/libel at News 12 Ct. that was eventually taken off TV and off the Internet that influenced tens of thousands of people in the community and even more nationwide, and it was then this nasty woman Wendy Higgins Chamber who then went to the Westport News to foment the same extreme lies/slander/defamation/libel **KNOWING I WAS ALREADY UNJUSTLY HARMED** that still exist to this day influencing tens and hundreds of millions of people worldwide. This nasty woman Wendy Higgins Chambers did not allow for Due Process to play out and went to the local media to foment extreme lies/slander/defamation/libel that tried and convicted me in forever life changing life-damaging ways before and after I received Due Process of Law. This veritably nasty woman Wendy Higgins Chambers knew nothing of the details of the arrest and the alleged incident that took place on Nov. 5 2017 – yes 4 months before the March 5, 2018 false arrest by the Westport Police and investigating and arresting Officer James Sullivan and **proceeded to cause EXTREME COVERAGE (emphasis on the word extreme according to the Ct. statutes)** and resulting Damages that not even the Westport Police intended as evident in their Press Release and Facebook postings to be presented as well as more evidence of Wendy Higgins Chambers’ MEAN-SPIRITED AND MALICIOUS SLANDER.

My first court date after my arraignment on March 14, 2018 the D.A. immediately reduced the Second Degree Breach of Peace charge to an “Infraction”, to which my lawyer and myself said “NO” because I broke no law. MY GOOD NAME FOREVER GONE NOW AND ALL EVIDENCE OF THIS SORDID DOXXING POINTS TO WENDY HIGGINS CHAMBERS.
