

Stephen R Swartz - Leader of Hearst

My name is **James Lawrence**. I am the Pro Se man who sued you all during 2020 for 2 Westport News articles language from a self-admitted “novice reporter” based on a crooked Arrest Warrant. A recent March 11, 2021 Decision dismissed my case. I am writing to ask you to review the documents submitted in the case and make a proper editorial decision based on the facts and to now make a proper editorial Decision based on the truth (not “*substantial truth*” legal bullshit) and remove what I referred to in the case as Article #2 and Article #3.

The following are undeniable facts.

- 1:** I have multiple federal judges pointing to the contents of this Arrest Warrant, an Arrest Warrant that never convicted me of the One Count Second Degree Breach of Peace arrest.
- 2:** I was never arrested before this fiasco in Connecticut and any alleged Incident Report involving a woman at a public market or café mentioned in the Warrant and in your articles were thoroughly investigated resulting in no arrest cases long closed.
- 3:** There are no women asking for this article.
- 4:** The only woman responsible for this article never used the word harass and as I show in a recent Exhibit she has no credibility (See Exhibit CCC, DDD).
- 5:** I am a certain victim of a crooked Arrest Warrant as I just began to show in recent Deposition to which your counsel Stephen Yuhan participated in.
- 6:** Your counsel knows the Arrest Warrant is not accurate in regards to number of woman who complained to Westport police (and only Westport) about me at a public market in the past.
- 7:** I was never arrested before this fiasco blown way out of proportion.
- 8:** I am soon to have the one and only “harassment” arrest – an alleged Email harassment arrest dismissed based on multiple false statements and perjury let alone more police misconduct.

I would have no problem of a proper re-writing of the one Email Harassment arrest without the inclusion on the crooked police warrant narrative and just sticking to Official Police Press Release. As I showed in a recent Exhibit, other media outlets disassociated themselves from the Breach of Peace Arrest Warrant narrative for in the end it is unproven and unprovable.

It is obvious that men are being persecuted in newer and newer ways. I did not do anything wrong and am a victim of being a narrative and that is it – a unprovable narrative.
